

TERMS AND CONDITIONS

The General Terms and Conditions set out below, together with the Customer's account application forms (the "Forms") and General Terms and Conditions may be amended from time to time, shall constitute the entire agreement under which the Customer's Account will be managed by Quantum Zenith Trustees & Investments Limited ("QZT").

Trust Account Opening and Management. The Customer has authorised and "QZT" has agreed to open and maintain a Trust account on behalf of the client.

2. Accuracy of Information.

The Customer confirms that the information supplied and any declarations made by the Customer (in the Forms, these General Terms and Conditions or otherwise from time to time) to "QZT" in connection with the Trust Account are true, accurate and complete.

3. Supply of Information.

The Customer undertakes to provide "QZT" with all information that "QZT" may reasonably require for the purpose of carrying out its duties as Trustee, including (where applicable) details of any change of residency or citizenship of the Customer.

4. Data protection/Privacy.

I hereby affirm that in line with the relevant laws on Data Protection in Nigeria, I consent to the collection and processing of my personal data/information in the absence of any fraud, duress, undue influence or coercion for the purpose of forming the basis of these terms and condition and other necessary data processing activities which may arise therefrom, including for the performance of this agreement between myself and QZT. I affirm that I have the requisite capacity under the law to consent to the collection and processing of my personal data.

I affirm that I am aware and take cognizance of my rights under the relevant Data Protection Laws in Nigeria which include the right to request for access, amendment, rectification or cancellation or destruction of my personal data/information, the right to lodge complaint with the relevant authority as well as the right to object to the processing of my personal data.

5. Approval of Statements.

6. Correspondence.

Any communication from "QZT" to the Customer shall be deemed to be validly delivered to the Customer if sent to the latest address indicated to "QZT" for this purpose by the Customer.

7. Value-backed Instructions.

The customer authorizes "QZT" to honour all written instructions issued on the Account provided such orders are in line with the Account mandate. If "QZT" receives invalid or unclear instructions from the Customer at any time, it may decline to act on them. In such an event, "QZT" will notify the Customer in writing and await the Customer's further instructions.

8. Lien.

In addition to any general lien or similar right to which "QZT" may be entitled under the general law. "QZT" shall have the right to, without prior notice to the Customer, combine or consolidate all or any of the Customer's accounts with "QZT" and set off or transfer any sum(s) or assets comprised in or attributable to any of the trust accounts towards the satisfaction of any of



the Customer's liabilities to "QZT" whether such liabilities be actual or contingent, primary or collateral, several or joint.

The customer agrees that "QZT" shall have no responsibility or any liability to the customer for any diminution of the customer's investment due to any future Government order, levy, law, tax or depreciation in the value of the funds due to inflation or the unavailability of funds due to exchange restrictions or similar causes beyond the control of "QZT".

10. Custody.

12. Termination of Agreement.

13. Force Majeure

14. Applicable Laws and Regulations

All transactions on the Account shall be subject to all applicable laws, rules, regulations, and the customs and practices of the exchange or market and clearing house, if any, on which such transactions are executed by "QZT".

15. Governing Law of Agreement
